Your letter of 15 June came as a very pleasant surprise, and I was very glad to hear from you, especially in view of the fact that I did not have an opportunity to say good-bye when you left Washington.

Thank you so much for your very courteous word about your service with us. I want to say on my own behalf how effective an officer you were and how much I enjoyed our very pleasant relations during all of the time that we were associated together. I hope, too, that we will see each other from time to time after we get our reserve officer activities established. We certainly want to maintain contact.

I dare say that you have made a wise decision to return to law practice, for in my opinion it is going to be some time before the unit which you were contemplating joining in the State Department will be on a firm foundation.

Everything is going along fairly well, but we are still handicapped by uncertainties and changes resulting from our attempt to return to a peace-time basis. A good many of your former associates in the commissioned service have returned to work in a civilian capacity, and I hope that we can make things so agreeable that they will be happy to be with us for a long time. Of course, the biggest obstacles we have to face are those over which we have no control or very little, such as Civil Service regulations, cuts in budgets, and so on, but I think we will manage.

Dear John:

I arrived home safely last Friday morning after a rather long journey, or at least it seemed long. We started off from Prestwick to go to Iceland, but had to turn back when more than half way there on account of improper landing conditions. Then we left Prestwick again, after a brief rest, for the Azores which was quite a long hop of twelve hours. We spent a few hours there and then took off for Bermuda which was another long hop of about twelve hours. Finally, after a short interval, we journeyed to New York just ahead of the heavy storm. I arrived there in the early hours of Friday morning and took a train to Washington.

Everybody is much taken up here with reorganizational matters and problems, and we hope to have things settled to a large extent in a few weeks.

I naturally called Mrs. Seaman the first thing and gave her a greeting from you. Please tell Roy that I called his wife and gave her a greeting too. She is coming in to chat with me some time soon. Also tell Frank Lewis that I called Mrs. Lewis and that she is fine and was glad to hear from him.
